

## LAKE DILLON FIRE PROTECTION DISTRICT

### PROCEDURE FOR INCLUSION IN THE DISTRICT

1. The Property Owner(s) or a Subdivision submits a notarized Application For Inclusion specifying the legal description of the property and payment of the appropriate fee as per the LDFPD Administration Fee Schedule.
2. The Application For Inclusion of a subdivision will be placed on the agenda for public hearing at the next regularly scheduled Board of Directors meeting provided there is adequate time for the public notice to be published in the Summit County Journal and Summit Daily News

The Application For Inclusion of an individual property will be scheduled in either March or September for public hearing before the Board of Directors. Board meetings are typically held on the third Tuesday of each month.

3. Notice of Public Hearing for Inclusion is placed in the Summit County Journal and the Summit Daily News.
4. The Board of Directors holds the public hearing and will act on the Application For Inclusion.
5. If approved, the Order For Inclusion is submitted to the District Court.
6. Upon approval of the court, The District will record the inclusion with the County Clerk and Recorder and file with the County Assessor.
7. A new updated boundary map of the LDFPD is ordered as required by statute.
8. Assessor's records are changed to reflect the inclusion into the LDFPD.
